ARTICLES OF INCORPORATION

OF

We, the undersigned natural persons of the age of twenty-one (21) years or more, at least two of whom are citizens of the State of Texas, acting as incorporators of a corporation under the Texas Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is DAVIS MOUNTAINS PROPERTY OWNERS ASSOCIATION, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are: To consider and deal by all lawful means with common problems involved in the collection of monthly and special maintenance assessments from each member of the corporation, and in providing for the maintenance, up-keep and improvements of the road rights-of-way, parks, other common areas and water wells, transmission lines, irrigation facilities and drainage for the common use and enjoyment of the members, in connection with the enjoyment and ownership by the members of their properties located in the DAVIS MOUNTAINS RESORTS Sub-Division of Jeff Davis County, Texas.
